Function Areas

Spanish Garden Steakhouse

Traditionally, renowned for its food offering since 1967. This Spanish style stucco building is a non-smoking environment, which offers full table service. This area is perfect for intimate style of dining, for either business or pleasure.

Staghorn Beer Garden

The Staghorn Beer Garden offers a relaxed atmosphere, with the convenience of the centrally located Staghorn Bar, and a "Big Screen" TV for your entertainment pleasure. A great place to meet friends for a casual drink or meal.

Staghorn Stage – Suitable for sit down functions only – max 50pax

Staghorn Deck – Suitable for Sit down or Stand up Cocktail Functions – max 30pax for sit down – Max – 40pax stand up cocktail

Substation no. 41

Want to be a part of the action? Have a small cocktail style gathering at our main bar! Enjoy the sophisticated atmosphere that the bar, music and service provides. Groove, classic style entertainment on Friday and Saturday nights from our resident DJ's. *(Bar service can not be booked out exclusively)

Substation Marquee

This area works great for Stand up Cocktail Functions or a Sit down Meal.

Stand up – Minimum of 50pax maximum of 120pax and requires a \$1000 minimum spend on food or bar.

Sit Down – Minimum of 40pax – Maximum 60pax – requires a \$1000 minimum spend on food or bar.

Substation Dry Bars and Lounge area

This area is very popular for birthdays or engagement functions it is suitable for stand up cocktail functions only.

Substation No 41 Bar

For large scale corporate functions, exclusive access of the whole Substation No 41 Bar. We do not recommend this for any function under 150pax. Please note this option will only be considered Sunday – Thursday. For Friday & Saturday exclusive enquires, please contact Hotel Management.

Private Bar Deck

Home of the famous “beer off the wood”. In the hub of the Hotel, it captures the ambience of the surrounding atmosphere of the originality of the Creek. The deck features its own drink service window for ease of access.

This area is suitable for Stand up cocktail functions and can be booked exclusively with a minimum of 35pax.

Front Plaza

Enjoy the ambience and cool breezes of the Brisbane River! This area is great for a range of functions and only one-step away from the rich history of the original Public Bar.

This area is suitable for sit down functions only – from minimum of 20pax – maximum of 50pax.

Side Plaza

This area offers a similar experience as the Front Plaza. It is an ideal area for birthday parties or work functions allowing your group a quiet atmosphere.

Suitable for sit down functions only – 30pax maximum

Confirmation

A booking is confirmed by signing the terms and conditions and filling out in full the Function Booking Form signing and returning to the Breakfast Creek Hotel. Once this is all received the Booking will be confirmed.

In certain exceptional and unforeseen circumstances it may be necessary to assign a different area for your function. BCH will endeavour to provide sufficient notice where possible.

Payment

BCH reserves the right to request a deposit for the booking. If a deposit is required, notification will be made at the time of enquiry. Payment will be accepted, by cash or credit card payment.

Full payment of all food and beverage must be made prior to the conclusion of the function. BCH accepts payment by cash, credit card or EFTPOS. BCH accepts American Express, Diners, Bankcard, MasterCard and Visa. Payment by cheque is acceptable if prior arrangements are approved and cheque is received by hotel at least fourteen (14) days prior to function.

Cancellation

Notification of cancellation must be made in writing to receive any refund of deposit. The following conditions apply based on period of notice for cancellation.

Notice given one month or more will receive a full refund.

Notice of between five (5) working days and one month will see 25% deposit forfeited.

Notice of less than five (5) working days will see 100% of deposit forfeited.

Final Function Details

All information regarding function set up is to be confirmed at least seven (7) days prior to function. This includes area set up, audio visual requirements, theme and décor. These requirements may come at an extra cost. BCH will advise at time of booking.

Responsible Service of Alcohol

All guests' must adhere to the current laws of the Queensland Liquor Licensing department. The Breakfast Creek Hotel management and staff, including our crowd controllers, support the responsible service of alcohol. Licensing laws prohibit the service of alcohol to underage and unduly intoxicated persons. Management has the right to refuse service to patrons displaying disorderly or intoxicated behaviour, and exercise regulatory conditions at any time during a function if alcohol consumption rate is excessive. Unduly intoxicated patrons displaying disorderly behaviour will be asked to leave the premises.

Minors

It is hotel policy that minors are allowed to attend a function until 10pm. All minors must be accompanied by a 'responsible adult'. A 'responsible adult' by law is a legal parent or guardian. This is non negotiable. Minors are not permitted to consume alcohol at any time. Minors are not permitted to order from any bar. Where possible please inform BCH of any minors attending your function at least five (5) working days prior to your event.

Entertainment

BCH provides in house entertainment, including DJ'S and Live Bands, as well as nightlife music played on the hotels sound Systems. Unfortunately BHC does not allow under any circumstances external entertainment. Including (DJS, Live Bands, or any other amplified music of any kind.)

Should you require any Audio Visual equipment please discuss prior to the event with our Functions Manager. BHC does not provide any Audio Visual equipment, and there are only certain areas of the Hotel where this can be used. Microphones are also unable to be used at any time in the Hotel.

Loss of Property

BCH will not accept any responsibility for any damage or loss of property left on the premises prior, during, or after the function. (Including any set up time required)
